

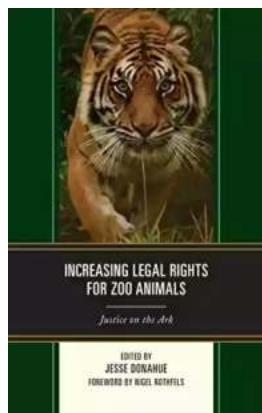

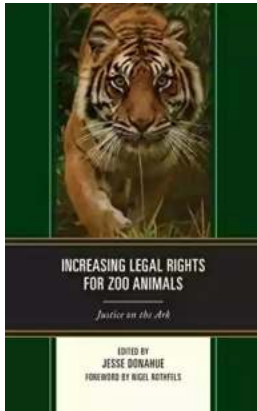

concrete dialogue and set of suggestions about how to extend legal rights to this group of animals.



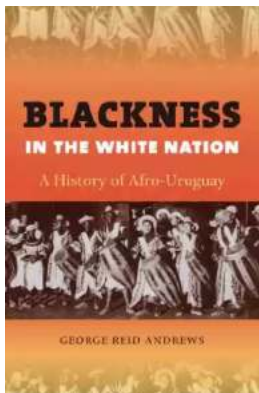

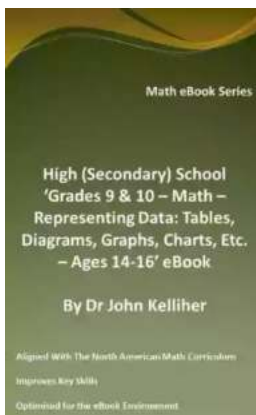
