

2) Choose the best answer among the remaining choices. Trust your "guess" because it is probably right, you just don't remember for certain, and you have no time to lose. When stuck on a question make your best guess OR skip it and hopefully you can get back to it. You are better off guessing though because you probably will not have time to return to the question and 1/4 > 0/4 odds.

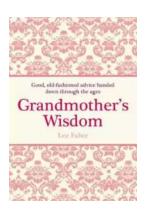
